In addition to their cultural commitment, CDN, Förderverein and IFKM also attach great importance to data security and discretion in the handling of member data. Therefore, we need your consent for the storage and processing of your personal data and for the publication of photos and videos.

We comply with the applicable regulations in this area.

#### Data processing of personal data requiring special protection

The personal data of the members collected with the enclosed form will be used for internal purposes. This personal data will neither be passed on to third parties nor used for advertising purposes.

Photographs and videos taken during CDN, Förderverein and IFKM events in which members appear are for internal purposes (e.g. information and intranet) and/or public relations.

#### Intended use of the data

##### **Information**

CDN members are informed by the local associations as well as by Förderverein and IFKM about rehearsals, performances, events, general organisational matters and events relevant to them. Members are informed via e-mail, in person and via the intranet.

##### **Organisation and data processing**

CDN, Förderverein and IFKM organise events, voice coaching, workshops, performances and concerts that members can attend regardless of location. Communication, registration for such events is organised by the local locations, as well as by IFKM and the Förderverein with the help of the association software "ClubDesk". The personal data of the members are stored in "ClubDesk" [www.clubdesk.ch](http://www.clubdesk.ch) and processed by the responsible processors on the part of IFKM, Förderverein and clubs. ClubDesk stores the data in a protected manner and does not pass it on to third parties, see <https://www.clubdesk.ch/de/datenschutz>. At each choir location there is at least one person who has access to the club's membership data in ClubDesk and is authorised to manage it. Members have the right to request information about their own data in the ClubDesk.

##### **Photo and video material for public relations work**

CDN, Förderverein and IFKM have websites and social media profiles that are used to publicly and regularly present performances and various activities. In addition, various online platforms are used for advertising, as well as posters, flyers, brochures, reports and the programme booklet, which are illustrated with photos in which members appear. These online and print media and the content published on them are important for our visibility and help us raise our profile.

For reasons of personal privacy, data protection and copyright, we require your consent for the storage and processing of data, as well as the publication of photos and video recordings in which you appear.
